# Federal Minimum Wage Increases July 24

On July 24, 2008, the federal minimum wage will increase from \$5.85 to \$6.55 per hour. This is the second of three increases generated by a May 2007 spending bill amending the Fair Labor Standards Act. The third and final increase will be effective on July 24, 2009, and will raise the federal minimum wage to \$7.25 per hour.

Not only must employers ensure they are paying all employees at or above the new rate, but they must also replace minimum wage posters to reflect the new minimum wage. Posters can be found on the Department of Labor's website. (http://www.dol.gov/esa/regs/compliance/posters/flsa.htm)

While many states apply the federal minimum wage, some states have minimum

wage requirements that exceed the federal amount. Employers should seek guidance on state-specific laws and regulations.

Employers can also expect to see a significant amount of new proposed legislation and regulatory amendments in the coming years. Coming soon are the Employee Free Choice Act (amending the National Labor Relations Act to facilitate more union organizing) and a bill that would amend the Americans with Disabilities Act to broaden the definition of "disability." Also pending are amendments to the regulations implementing the Family and Medical Leave Act.
